ORDER :-

In the letter read above, the Commissioner of e-Governance, Tamil Nadu e-Governance Agency has requested the Government to reimburse the manpower cost of Rs.3,33,066/- for the period of 7 months (i.e. 01.09.2020 to 31.03.2021) inclusive of GST to Tamil Nadu e-Governance Agency as raised by the National Informatics Centre

The Government after careful consideration, accepted the request of the Commissioner of e-Governance, Tamil Nadu e-Governance Agency and sanction a sum of Rs.3,33,066/- (Rupees Three lakhs, thirty three thousand and sixty six only) towards the Tamil Nadu e-Governance Agency reimbursement of manpower cost raised by the National Informatics Center for the maintenance of Post Matric Scholarship portal for the period of 7 months (i.e. 01.09.2020 to 31.03.2021).

3. The expenditure sanctioned in Para 2 above, shall be debited under the following Head of Account:
