ORDER:-

In the Government Order first read above, Administrative Sanction was accorded among others, for the construction of ITI building and ITI hostel at Vadakarai, Tiruvallur District at a total cost of Rs.8.78 crore. In the above said order, a sum of Rs.26,02,000/- has been sanctioned to meet out the expenditure for the financial year 2015-2016. Further, it has been ordered that Hostel building will be constructed at a cost of Rs. 1 crore.

2. In the Government Order second read above, Financial Sanction was accorded for the construction of ITI building and to meet out staff & other expenditure.

3. In the letter third read above, the Managing Director, TAHDCO has requested the Government to accord financial sanction of Rs. 100 lakh for construction of ITI hostel building at Vadakarai, Tiruvallur District as detailed below:-

In the letter 4th read above, the Director, Adi Dravidar Welfare has stated that during the financial year 2015-2016, the sanctioned amount of Rs.1,00,00,000/- for the construction of ITI hostel building at Vadakarai, Tiruvallur District could not be drawn and surrendered due to some administrative reasons. Further, the Director, Adi Dravidar Welfare has stated that during the financial year 2016-2017 and 2017-2018 no amount has been allocated for the construction of ITI hostel building at Vadakarai, Tiruvallur District. Accordingly, he requested the Government to issue the order for financial sanction of an amount of Rs.1,00,00,000/- for the construction of ITI hostel building at Vadakarai, Tiruvallur District at an early date.

5. The Government, after careful examination, have decided to accord Financial Sanction of Rs.1,00,00,000/- (Rupees one crore only) for the construction of ITI hostel building at Vadakarai, Tiruvallur District during the financial year 2019-2020.

6. The expenditure sanctioned in para-5 above shall be debited to the following head of account:-

7. The Director, Adi Dravidar Welfare is authorized to draw and release the amount to TAHDCO to execute the works sanctioned in para-5 above. The amount sanctioned in para-5 above shall not be paid in cash but shall be credited to the following head of account by Contra credit:-

An amount of Rs. 1,00,00,000/- will be provided in RE/FMA 2019-2020, however, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimate 2019-2020. Pending provision of such funds, the Director, Adi Dravidar Welfare is authorized to draw and disburse the amount authorized in Para - 5 above. He is also directed to include this item of expenditure while sending the proposal for RE/FMA 2019-2020 and also send necessary draft explanatory note for inclusion of this expenditure in the Supplementary Estimate 2019-2020 to Government in Finance (AD&TW) / B.G.I) Department at the appropriate time without fail.

9. This order issues with the concurrence of Finance Department vide its U.O.No. 30146/AD&TW/2019, dated 26.07.2019 and Additional Sanction Ledger No.736 (Seven Hundred and Thirty Six).
