## ORDER:-

The Director of Seed Certification and Organic Certification in his letter second read above has stated that organic agriculture is receiving increased attention among farmers, producers, processors, traders, exporters and consumers. Growing consciousness of health hazards due to the possible contamination of farm produce from the use of chemical fertilizers have immensely contributed to the revival of this form of farming during the last five years. To provide a focussed and well directed development of Organic agriculture and quality products, Government of Tamil Nadu created a new Department of Organic Certification by additionally designating Department of Seed Certification for the purpose of carrying out inspection and certification of clearly indentified production or processing system that has been methodically assessed and conforms to the specified requirements. Inspection and certification is carried out in accordance with "National Programme for Organic Production" (NPOP) norms.

2. He has also stated that training is necessary to create awareness on Organic Certification, to give exposure on latest development and trend in Organic Certification, to offer advice to the certified operators regarding compliance with Organic standards. Hence, it is proposed to conduct a training on fourth week of January, 2017 at Farmers Residency, Tamil Nadu Agricultural University and the item wise expenditure for the training is as follows:-

- 3. The Director of Seed Certification and Organic Certification has therefore requested the Government to issue orders for conducting training to Organic farmers/ Operators who have registered with the Department of Organic Certification. He has also requested to permit him to draw an advance under article 99 of Tamil Nadu Financial Code Volume I from the amount of Rs.58,000/- to meet out the expenditure in connection with training to the Organic farmers / Operators.
- 4. After careful examination, the Government accept the proposal of the Director of Seed Certification and Organic Certification and sanction a sum of Rs.58,000/- (Rupees fifty eight thousand only) for conducting training to Organic farmers / Operators who have registered with the Department of Seed Certification and Organic Certification and permit him to draw an advance under article 99 of Tamil Nadu Financial Code Volume-I to meet out the expenditure in connection with training to the Organic farmers and Operators.
