ORDER:

In the G.O.first read above, orders have been issued sanctioning matching grants to Muslim Women Aid Society every year equal to the donation collected by the society.

2. In the letter 2nd read above, the President, Muslim Women Aid Society and Collector of Chennai (i/c) has stated that the above society has collected a sum of Rs.4,21,979/- as donations during the year 2011-2012 and requested the Government to sanction a sum of Rs.4,21,979/- being the amount equivalent to the donations collected by the above society during the year 2011-2012.

3. The Government after careful examination accept the proposal of the President, Muslim Women Aid Society and Collector of Chennai (i/c) and accordingly sanction a sum of Rs.4,21,979/- (Rupees four lakhs twenty one thousand nine hundred and seventy nine only) being the Government matching grant equal to the amount collected by the Muslim Women Aid Society by way of donations etc., during the year 2011-2012.

4. The amount sanctioned in para-3 above shall be debited to the head of account "2235 Social Security and Welfare-60-Other Social Security and Welfare Programmes -200 - Other programmes -I. Non Plan-AJ Assistance to Muslim Gosha Women Aid Society-09. Grants-in-Aid-01- Grants for Current Expenditure" (D.P.Code-2235 60 200 AJ 0910).

5. Necessary additional funds for a sum of Rs.3,21,979/- over and above the provision made in Budget Estimate 2013-2014 will be provided in Revised Estimate / Final Modified Appropriation 2013-2014 and pending provision of such funds, the Assistant Pay Master (carnatic stipends) Chennai-1 is authorised to draw the amount sanctioned in para 3 above and disburse it to the President Muslim Women Aid Society and Collector of Chennai(i/c). He is also requested to include this item of expenditure while sending proposal for Revised Estimate / Final Modified Appropriation 2013-2014 to Government in Finance Department without fail.

6. This order issues with the concurrence of Finance Department vide its U.O.No.20189/Fin(BCMBC)/2013,dated:30.4.2013 with ASL No. 145 (One hundred and forty, five)
