### **ORDER:**

In the reference first to fourth read above, the Registrar, State Consumer Disputes Redressal Commission has stated that the Government of India have decided to extend financial assistance to strengthen the Consumer Fora under a new scheme 'Strengthening of Consumer Fora'. The Registrar, State Consumer Disputes Redressal Commission has requested the Government to send the proposal to Government of India seeking financial assistance under the scheme 'Strengthening of Consumer Fora' for the construction of own building to

the State Commission, Chennai and District Consumer Disputes Redressal Fora, Chennai (North), (South), Krishnagiri, Namakkal and Srivilliputhur and also requested necessary administrative sanction with funds be obtained from the Government of India to State Consumer Disputes Redressal Commission. The amount requested by the Registrar, State Consumer Disputes Redressal Commission are as follows:

3. Based on the request of Government of Tamil Nadu, the Government of India in the reference 5<sup>th</sup> read above, has conveyed the sanction of the President for payment of Rs.1,96,79,047/- as first installment out of the total approved financial assistance of Rs. 394.20 Lakh for the construction of own building to the State Commission, Chennai and District Consumer Disputes Redressal Fora at Chennai (North), (South), Krishnagiri, Namakkal and Srivilliputhur. The break-up details are given below:-

4. Total amount requested by Government of Tamilnadu based on the estimate prepared by the Public Works Department and total financial assistance approved by the Government of India are as follows:

5. The Government after careful examination, decided to accept the request of the Registrar, State Consumer Disputes Redressal Commission in para 1 above. Accordingly, Government accord administrative sanction for the total approved financial assistance of Rs. 4,56,75,000/- (Rupees Four Crore Fifty Six Lakh and Seventy Five thousand only) including share of the Government of India of Rs.3,94,20,000/- (Rupees Three Crore Ninety Four Lakh and Twenty Thousand only). The Government also sanction the deficit amount of Rs.62,55,000/- (Rupees Sixty Two Lakh and Fifty Five Thousand only) from the State Fund. The Government also accord sanction for the release of Government of India's 1<sup>st</sup> installment of Rs.1,96,79,047/- (Rupees One Crore Ninety Six Lakh Seventy Nine Thousand and Forty Seven only) for the construction of own buildings to the State Commission, Chennai and District Consumer Disputes Redressal Fora at Chennai (North), (South), Krishnagiri, Namakkal and Srivilliputhur.

6. The amount sanctioned in para 5 above shall be debited into the following Head of account:-

4070-00 – Capital outlay on other Administrative Services – 800 –  
Other Expenditure– Schemes in the Eleventh Five Year Plan – III  
Centrally sponsored. SB – Cost of land for accommodation of the  
District Consumer Forum Buildings – 16 – Major works

7. The expenditure sanctioned in para 5 above shall constitute an item of “New Instrument of Service” and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates for the year 2011-12. Pending approval of the Legislature, the expenditure shall initially be met by drawl of an advance from the Contingency Fund. Orders Regarding this will be issued by the Finance (BG.I) Department separately. The Registrar, State Consumer Disputes Redressal Commission shall apply to the Government in Finance (BG.I) Department in prescribed format along with a copy of this order for sanction of an advance from the Contingency Fund. The Registrar, State Consumer Disputes Redressal Commission shall also send necessary draft explanatory notes for inclusion of the expenditure in the Supplementary Estimates for the year 2010-11, without fail.

8. The Chief Engineer, Public Works Department (Buildings) is authorized to draw and disburse the amount sanctioned in para 5 above.
