### **ORDER :**

In the Government order first read above, orders were issued to merge the post of copyist with that of typist in the Tamil Nadu Judicial Ministerial Service.

2. In the Government order second read above, orders were issued revising the time scale of pay to the post of Typist from Rs.5,200 – 20,200 + G.P.2,000 to Rs.5,200 – 20,200 + G.P.2,400/-.

3. In the reference fourth read above, the Registrar(i/c), State Consumer Disputes Redressal Commission has stated that only one post of Copyist sanctioned to State Consumer Disputes Redressal Commission and the staff has been posted as Copyist in District Consumer Disputes Redressal Forum, Chennai (South), which is having heavy pendency of cases and heavy work load. According to the Adhoc rules, the Special Rules applicable to the posts in the Tamil Nadu Judicial Ministerial Service will also apply to the temporary posts including the post of Copyist in the State Consumer Disputes Redressal Commission. The post of Copyist and the nature of work of that post is like that

of the post of Copyist in the Judicial Department in the Tamil Nadu Judicial Ministerial Service Rules. Copyist is receiving the scale of pay of Rs.5,200 – 20,200 + G.P.Rs.2,000/-.

4. The Registrar (i/c), State Consumer Disputes Redressal Commission has requested the Government to issue orders for merging the post of Copyist with that of the Typist as per G.O.(Ms) No.1006, Home (Courts V) Department, dated 03.07.2007 and the pay of Copyist may be regulated in the pay band eligible to the cadre of Typist i.e. Rs.5,200-20200 + Grade Pay Rs.2,400/- with effect from 10.09.2008 and monetary benefits with effect from 01.02.2011.

5. Meanwhile, in the Government Order third read above, by implementing the recommendations made by the Pay Grievance Redressal cell in respect of the State Consumer Disputes Redressal Commission the scale of pay for the post of Amin, Examiner and Copyist has been revised from Rs.5200 – 20200 + G.P. 2000 to Rs.5200 – 20200 + G.P. 2400 notionally w.e.f. 1.1.2006 with monetary benefit from 1.4.2013.

6. The Government after careful examination have decided to accept the proposal of the Registrar (i/c), State Consumer Disputes Redressal Commission at para 4 above. Accordingly, the Government have ordered for the merger of the post of Copyist with that of Typists in the Tamil Nadu Judicial Ministerial Service and to regulate the pay of Copyist with reference to the Government order third read above.

7. This order issues with the concurrence of Finance Department vide its U.O. No. 27089/PC/2014, dated 26.5.2014.
