ORDER:

In the Government Order first read above, orders were issued sanctioning a sum of Rs.125.00 lakhs (One Twenty Five lakhs only) towards the activities for the Centenary celebration of Tamil Nadu Forest Academy, Coimbatore. Out of Rs.125.00 lakhs (One Twenty Five lakhs only) an amount of Rs.100.00 lakhs (Hundred lakhs only) was sanctioned for the Construction of Centenary Auditorium at Tamil Nadu Forest Academy Campus at Coimbatore. The work was entrusted to the Public Works Department. The Public Works department has spent an amount of Rs.0.29 lakhs (Rupees Twenty Nine lakhs only) towards advertisement charges during the year 2012-2013. The unspent amount of Rs.99.71 lakhs (Rupees Ninety Nine lakhs and Seventy One thousand only) during 2012-2013 has not been surrendered under the head of account :-

“4406 01 070 JB 16 Major Works” during 2012-2013.

2. The Principal Chief Conservator of Forests in his letter second read above has stated that the Public Works Department has completed the major works, but no payment has been made to the contractor due to non allotment of fund to the Public Works Department. Hence, the Principal Chief Conservator of Forests has requested to sanction an amount of Rs.99.71 lakhs (Rupees Ninety Nine lakhs and Seventy One thousand only) for carrying out the construction of Centenary Auditorium at Tamil Nadu Forest Academy Campus at Coimbatore during 2014-2015.

3. The Government after careful examination accept the proposal of the Principal Chief Conservator of Forests and accord revalidation for a sum of Rs.99.71 lakhs (Rupees Ninety Nine lakhs and Seventy One thousand only) sanctioned in the reference first cited during the year 2012-2013 under Part-II Scheme to complete the work construction of Centenary Auditorium at Tamil Nadu Forest Academy Campus at Coimbatore during the year 2014-2015.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account :-

“4406 Capital out lay on Forestry and Wildlife 01-Forestry 070 Communication and Building - Schemes in the Twelfth Five Year Plan II – State Plan – JB. Construction of Buildings 16 Major works (DPC 4406 01 070 JB 1600)”

5. Necessary funds will be provided in Revised Estimate / Final Modified Appropriation 2014-2015, to meet the expenditure sanctioned in para 3 above. Pending provision of such funds in Revised Estimates / Final Modified Appropriation 2014-2015, the Principal Chief Conservator of Forests is authorised to incur the above expenditure through Letter of Credit. This should be brought to the notice of Legislation by specific inclusion in the Supplementary Estimates 2014-2015. The Principal Chief Conservator of Forests is also requested to send the necessary draft explanatory notes to Finance Department to include the above expenditure as pending provision in Revised Estimate / Final Modified Appropriation 2014 – 2015. Supplementary Estimates 2014-2015 to Government Finance (BG.I and AHD&F) Department at the appropriate time.

6. The Principal Chief Conservator of Forests is also requested to ensure that the amount sanctioned for the above works is utilized in the full during the year 2014-2015 and send a utilization certificate to Government as soon as the work is completed.

7. This order issues with the concurrence of Finance Department vide its U.O. No.35651/AH&F/2014, dated.16.07.2014 and with Additional Sanction Ledger No.706 (Seven hundred and six).
