ORDER :

In the Government Orders first to eight read above, orders were issued fixing the rate of interest for accumulations at the credit of the subscribers to the Contributory Pension Scheme for the period upto 31-03-2017.

2. In the Government Order ninth read above, the rate of interest for General Provident Fund was fixed at the rate of 7.9% (Seven point nine per cent) for the period from 1st April 2017 to 30th June 2017.

3. The Government, now direct that the rate of interest on the accumulations at the credit of the subscribers to the Contributory Pension Scheme shall be fixed at **7.9%** (Seven point nine per cent) for the period from 1st April 2017 to 30th June 2017.
