Contributory Pension Scheme – Final Authorisation – Approval of CPS final authorization – Permission to Chief Accounts Officer – Granted – Orders – Issued.

#### ORDER:

In the Government Order first read above, orders were issued for settlement of accumulation under Contributory Pension Scheme in respect of Contributory Pension Scheme subscribers retired/resigned, died and terminated from service by prescribing the procedures and indicating the relevant head of accounts. It was also ordered that the Director of Treasuries and Accounts, Chennai shall issue authorization based on the CPS final account slip issued by the Government Data Centre.

- **2.** In the Government Order second read above, sanction was accorded temporarily for one post of Chief Accounts Officer and one post of Assistant Accounts Officer for Contributory Pension Scheme (CPS) Cell and the duties and responsibilities were also assigned for the post of Chief Accounts Officer and Assistant Accounts Officer.
- 3. Among others, the duty of approval of Contributory Pension Scheme final settlement claims as per the Government Order first read above has also assigned to the post of Chief Accounts Officer. Hence, in Government letter third read above, the Principal Secretary / Commissioner of Treasuries has requested that the Chief Accounts Officer may be authorized to approve the Contributory Pension Scheme final payment authorizations instead of by the Director of Treasuries and Accounts as ordered in Government Order first read above.
- **4.** After careful consideration, permission is accorded to the Chief Accounts Officer, Contributory Pension Scheme (CPS) Cell to sign the CPS final payment authorizations as per the duties and responsibilities assigned

in the Government Order second read above after obtaining approval of Additional Director (NPS), CPS Cell, Government Data Centre.
