ORDER:

In the Government Order first and second read above, the Government have issued orders for the implementation of the Integrated Financial and Human Resource Management System (IF&HRMS) Project, which envisages integration of both Financial and Human Resource Management. As the System contemplates end to end solution for all financial activities, various rules, procedure for drawing payments from Treasuries are being inbuilt in the system. The objective of this Project is to remove various systemic deficiencies in the manual legacy system of operation and optimizing efficiency through comprehensive business process re-engineering.

2) Accordingly, the Principal Secretary/Commissioner of Treasuries and Accounts has proposed for amending Subsidiary Rule 10 (b) under Treasury Rule 10 of Tamil Nadu Treasury Code Volume-I.

3) The Government after careful examination has decided to accept the proposal of the Principal Secretary/Commissioner of Treasuries and Accounts and issue the following notification:-

NOTIFICATION

In exercise of the powers conferred by Article 283 (2) of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Subsidiary Rule 10 (b) under Treasury Rule 10 of Tamil Nadu Treasury Code, Volume-I.

The amendment hereby made shall be deemed to have come into force on the 04th October 2019.

AMENDMENT

In the said Tamil Nadu Treasury Code, Volume-I, in Subsidiary Rule 10 (b) under Treasury Rule 10 the following shall be substituted:-

“When a payment to the Government, involved in the same transaction, is to be credited partly to one head of account and partly to another head, one single e-chalan shall be used for entering multiple receipt heads of account and the amount shall be credited to each of the appropriate various receipt head”.
