**2.** In the Government Order eighth read above, the rate of interest for General Provident Fund was fixed at the rate of 8.0% for the period from 01.01.2017 to 31.03.2017.

**3.** The Government now direct that the rate of interest on the accumulations at the credit of the subscribers to the Contributory Pension Scheme shall be fixed at 8.0% (Eight point Zero per cent) for the period from 1<sup>st</sup> January 2017 to 31<sup>st</sup> March 2017.
