### **ORDER:**

In the Government Order first read above, orders were issued launching a New Health Insurance Scheme 2014 for Pensioners (including spouse)/Family Pensioners on a CASHLESS basis, with provision to avail Medical assistance upto Rs.2,00,000/- for a block period of four years. (2014 to 2018).

**2.** In the Government Order second read above, orders were issued for the implementation of New Health Insurance Scheme 2014 for Pensioners (including spouse)/Family Pensioners. In para 6 of the Government Order, it has been ordered to pay the insurance premium by the Government debiting the expenditure to the following Head of Account under Demand No.50. Pension and Other Retirement Benefits :

#### **“2075.00. MISCELLANEOUS GENERAL SERVICES**

- 800. Other Expenditure
  - I. Non-Plan
  - IJ. New Health Insurance Scheme, 2014 for Pensioners / Family Pensioners.
- 10. Contributions
  - 2. Insurance Premium

3. In the letter third read above, the Principal Accountant General, Chennai has informed that the “New Health Insurance Scheme 2014 for Pensioners (including spouse)/Family Pensioners” classified under 2075.00. Miscellaneous General Services – 800. Other Expenditure” under the sub-head “IJ” may be classified under “2235. Social Security and Welfare – 60. Other Social Security and Welfare Programmes – 110. Other Insurance Schemes” instead of “2075.00.800”.

4. Based on the clarification sought for from the Accountant General (A&E) in the Government letter fourth read above, the AG(A&E) Chennai-18 in the reference fifth read above has informed that the New Health Insurance Scheme, 2014 for Pensioners (including spouse) / Family Pensioners could be reclassified under 2071- 01-800.

5. Accordingly the Government issue the following amendment to the Government Order second read above:
