ORDER:-

The Member Secretary (FAC), Tamil Nadu State Council for Higher Education in the letter third read above, has stated that it has been requested by Government to place the subject, whether B.Tech. (Fashion Technology) offered by Sona College of Technology, affiliated to Anna University, is equivalent to Diploma in Textile Technology for the purpose of employment in Public Service based on the orders issued by the Hon'ble High Court of Madras in W.P. No. 9796 of 2020 dated 30.7.2020. The subject was placed in the meeting of subject experts held on 14.10.2020 and Percentage of similarity between the content of syllabi under consideration is 63.29%. It was recommended that the Programme B.Tech. (Fashion Technology) offered by Sona College of Technology (Anna University) during the period 2007-2011 is not Equivalent to the programme Diploma in Textile Technology. He has forwarded the resolution passed by the 5th Equivalence Committee (through Circulation) dated 17.12.2020 under the Chairmanship of the Principal Secretary to Government, Higher Education Department, on the equivalence of Degrees offered by various Universities/ Educational Institutions to the similar Degrees for the purpose of employment in Public Services and requested the Government to issue orders in the matter.

2. The Government, after careful examination, approve the following resolution passed in the 5th Equivalence Committee (through Circulation) dated 17.12.2020 under the Chairmanship of Principal Secretary to Government,

Higher Education Department and direct that the following degree offered by various Universities / Educational Institutions be not equivalent to the Degree mentioned therein:-

Public Services – Educational Qualification – Consideration of B.Tech. (Fashion Technology) offered by Sona College of Technology (Anna University) as to whether equivalent to Diploma in Textile Technology for the purpose of employment in Public Services.	Not Equivalent

3. The degrees so placed in the Equivalence Committee are considered as basic degree / post graduate degree, as the case may be, as per University Grants Commission norms.
