ORDER:

The Director of Medical and Rural Health Services in her letter read above has stated among others that the State Planning Commission has called for innovative proposal under the Tamil Nadu Innovation Initiative Schemes (TANII) for the year 2018-2019. Accordingly, she has submitted the proposal to the State Planning Commission for the establishment of Hi-Tech Oto Laryngology OP Department in 29 District Headquarters Hospitals and 25 Sub District Hospitals. After a series of discussion, the State Planning Commission has recommended to establish the Hi-Tech Oto Laryngology OP Department at Government Headquarters Hospital, Mettur Dam, Salem District and two Government Hospital at Arupukkoatai, Virudhunagar District, at Government Hosital Tirupatur, Vellore District at a cost of Rs.30.00 lakh.

2. The Director of Medical and Rural Health Services has furnished the total cost required for the establishment of one Hi-Tech Oto Laryngology OP Department are as follows:-

3. The Director of Medical and Rural Health Services has, therefore, requested the Government.

- i. To permit her to establish Hi-Tech Oto Laryngology OP Department in Government Headquarters Hospital at Salem (Mettur Dam) and Government Hospitals, Arupukkottai and Tirupathur under the Tamil Nadu Innovation Initiative Schemes (TANII) for the year 2018-2019.
- ii. She has also required to permit her to purchase the above said equipments required for implementation of the programme through the Tamil Nadu Medical Services Corporation Ltd., Chennai.

4. The Government have examined the proposal of the Director of Medical and Rural Health Services in the light recommendation of the State Planning Commission. The Government accordingly, do and hereby direct that the Director of Medical and Rural Health Services is permitted to establish of Hi-tech Oto Laryngology OP Department in Government Headquarters Hospital at Mettur Dam and Government Hospitals at Arupukkottai and Tirupathur through Tamil Nadu Innovation Initiative Schemes (TANII) funds from the State Planning Commission at a cost of Rs.30.00 lakh (Rupees Thirty lakh only). (Rs. 10.00 lakh each for 3 hospital) The Director of Medical and Rural Health Services is also permitted to procure the equipment mentioned at para 2 above, which are required for establishing the Hi-Tech Oto Laryngology OP Department through the Tamil Nadu Medical Services Corporation Ltd., Chennai.

5. The amount sanctioned in para 4 shall be met from the State innovation fund and debited to the following head of account:

“2210-Medical and Public Health-01 Urban Health Services – Allopathy-110 Hospital and dispensaries – State’s Expenditure – ES Establishment of Hi-Tech Otorhino Laryngology Outpatient Department in Secondary Care Hospitals Under State Innovation Fund-19 Machinery and Equipments – 01 Purchase”.

The above expenditure shall be adjusted by deducting under the following head of account:
