**ORDER:**

In the letter read above, the Director of Medical and Rural Health Services has sent proposal for creation of certain posts in Government Hospital, Sivakasi and stated that the conversion of burns ward in to "Centre of Excellence" at Government Hospital, Sivakasi is almost over with the new buildings and the renovated old buildings which are going to be use for public in a short time. The new building is having the following additional beds.

2. The Director of Medical and Rural Health Services has justified that as far as sanction of staff is concerned, looking at the recent times, many doctors, staff and other technical posts have been sanctioned as new posts to this hospital, but not a single Ministerial staff has been sanctioned and the hospital is functioning with only two Ministerial staff, i.e. one Office Superintendent and One Assistant which were sanctioned more than two decades ago. Since then no Ministerial Staff post has been sanctioned, despite other staff sanctioned for the above hospital. He has also justified that the Pharmacist post is essential to look after all the Para Medical related works and requested for the creation of eight Ministerial staff and three Pharmacist posts for the smooth and fair functioning of the Government Hospital, Sivakasi.

3. The Government have examined the proposal of the Director of Medical and Rural Health Services in detail and accord sanction to create one post of Junior Assistant and one post of Pharmacist to the Government Hospital at Sivakasi, Virudhunagar District as detailed in the annexure to this order for a period of one year from the date of filling up of the post at an average cost of Rs.10.51 lakhs per annum.

4. The expenditure sanctioned in para 3 above shall be debited in the following Head of Account.

"2210-Medical and Public Health – 01-Urban Health Services - Allopathy- 110 – Hospitals and Dispensaries -- I Non Plan AB Taluk Headquarters Hospitals - 01 Salaries". (DPC 2210-01-110-AB-0104)

5. Necessary funds will be provided in RE / Final Modified Appropriation 2015-2016. Pending provision of such funds, the Director of Medical and Rural Health Services, Chennai-6 is authorized to draw and incur the expenditure sanctioned in para 3 above. The Director of Medical and Rural Health Services is directed to include this expenditure while sending the proposal for RE / Final Modified Appropriation 2015-2016 to Government in Finance Department without fail.
