



## **ABSTRACT**

Tamil Nadu Medical Service – Selection of candidates for temporary appointment to the post of Assistant Surgeon (Dental) (Speciality) through Medical Services Recruitment Board – Ordered – Amendment – Issued.

### **ORDER:**

In the Government Orders first to third read above, among others, orders were issued appointing 36 candidates as Assistant Surgeon (Dental) (Specialty) in the Tamil Nadu Medical Service.

2. In the Government Order fifth read above, 34 candidates were appointed as Assistant Surgeon (Dental) (Specialty) subject to the outcome of the Writ Petitions W.P.(MD)No.18661/2014, W.P.(MD)No.18986/2014 and W.P.No.30293 and 29992 of 2014 pending before the Hon'ble High Court of Madras and Madurai Bench of Madras High Court.

3. The Member Secretary, Medical Services Recruitment Board in the reference sixth read above has stated that the candidates were provisionally selected according to marks obtained in the competitive examination, duly following communal rotation, subject to fulfilling the minimum qualification such as educational qualification, age and registration in Tamil Nadu Dental Council etc. However, Dr.M.Ramesh and Dr.V.Brindalakshmi qualified with MDS had filed writ petitions (W.P.Nos.26739 and 26749 of 2014) in the High Court of Madras with prayer to appoint them as Assistant Surgeon (Dental) (Specialty) in the category of MDS with any Speciality with effect from 18.07.2014 with all consequential benefits.

4. The Hon'ble High Court of Madras in its order dated:05.12.2014 in the above Writ Petitions has directed the respondents to conduct counselling for the petitioners and accommodate them by giving appointment orders, subject to availability of vacancy.

5. The Member Secretary, Medical Services Recruitment Board has stated that in pursuant to the orders of the Hon'ble Court, the eligibility of the candidates have been

examined including all such similarly placed applicants. She has sent necessary proposal to the Government in this regard.

6. She has also stated that they have registered their names in the Tamil Nadu Dental Council after the stipulated date. Due to the pending litigations on the date of registration of MDS degree in the Tamil Nadu Dental Council, the names of the above candidates have been overlooked in their respective specialty and communal category and therefore, consequently the candidates who have secured lesser marks had been included in the selection list. Now, as per the interim orders of the Hon'ble Court, the petitioners may be considered for selection to the post of Assistant Surgeon (Dental) (Specialty) in their respective specialty.

7. Among the above candidates, Dr.M.Ramesh has already been appointed as Assistant Surgeon (Dental) (Speciality) vide Government Order fifth read above.

8. The Member Secretary, Medical Services Recruitment Board has therefore requested the Government to issue necessary amendment to G.O.(3D) No.72, Health and Family Welfare (B2) Department, dated:18.7.2014 to include the names of Dr.V.Brindalakshmi and Dr.Praveen by cancelling the appointment of Dr.Revathy and Dr.Muthukumar.

9. The Government have examined the proposal of the Member Secretary, Medical Services Recruitment Board and decided to accept the same. Accordingly, in partial modification of orders issued in Government Order second read above. Dr.V.Brindalakshmi (Communal Rotation GT W) Register No.1009558 and Dr.Praveen (Communal Rotation SC) Register No.1017004 are temporarily appointed as Assistant Surgeon (Dental) (Specialty) and their names are placed against Serial No.19 and Serial No.30 respectively in the annexure to the said Government Order subject to the outcome of W.P.No.26739 and 26749/14.

10. The Government also order that the appointment of Dr.Revathy and Dr.Muthukumar mentioned in Serial No.19 and 30 respectively in the annexure to the Government Order second read above stands cancelled.
