ORDER:

In the circumstances reported by the Director of Medical Education, in her letter second read, above the Government accord sanction for revival for the one temporary post of Steno Typist Grade-III attached to Chengalpattu Medical College, Chengalpattu which was originally created in the Government Order first read above, with effect from the date of filling up of the post i.e., 28.02.2014.
