ORDER:-

In the Government order first read above, sanction was accorded for the purchase of one new college bus at a cost of Rs.19,23,749/-(Rupees Nineteen Lakh Twenty Three Thousand Seven Hundred and Forty Nine only).

2. The Director of Medical Education in her letter second read above has stated that the college bus could not be purchased due to belated submission of bill in the Pay and Accounts Office, and subsequently the funds have been surrendered to Government. She has also informed that the cost of the college bus has escalated from Rs.19,23,749/- to Rs.20,49,173. She has also sent the quotation for the purchase of the following specification of vehicle obtained from the Tamil Nadu State Health Transport Department, Guindy Chennai.

Model of the Vehicle

: Ashok Leyland Lynx BS4,

4900m WB 49 + D Seater

fully built bus

Cost of the Vehicle

: Rs.20,49,173/-

The Director of Medical Education has requested necessary budget provision and sanction order for the purchase of the above said college bus.

3. After carefully examing the proposal of the Director of Medical Education, the Government accord revised sanction for a sum of Rs.20,49,173/- (Rupees Twenty Lakh forty nine thousand one hundred and seventy three only) towards the purchase of one new Ashok Leyland BS4, 4900mm WB 49+D seater fully built bus, for the use of the students of Madras Medical College, which includes the amount of Rs.19,23,749/- already sanctioned in the Government order first read above and surrendered in FMA 2014-15 to Government.

- 4. The expenditure sanctioned in para 3 above shall be debited to the following Head of Account:
 - 2210 Medical and Public Health 05 Medical Education Training and Research 105 Allopathy I Non-Plan AA Chennai Medical College 21 Motor Vehicles 01 Purchase.

Pending provision of funds in RE/FMA, the Director of Medical Education is authorized to draw and disburse the amount sanctioned in para 3 above. The Director of Medical Education is requested to include the above expenditure while sending proposal for RE/FMA 2015 -16 to Government in Finance (Health-II) Department without fail.
