2. The Director of Medical Education has further stated that, the Managing Director, ELCOT has sent the invoice for an amount of Rs.4,24,291/- (Rupees Four lakh twenty four thousand two hundred and ninety one only) towards the arrangements for video conferencing equipments with related accessories at 11 New Medical Colleges as mentioned above and New Building of Central Institute of Classical Tamil, Chennai for inauguration through Video Conferencing.

3. The Director of Medical Education has therefore requested the orders of Government to accord sanction for a sum of Rs.4,24,291/- (Rupees Four lakh twenty four thousand two hundred and ninety one only) incurred towards the arrangements for video conferencing equipments with related accessories for the inaugural function of 11 New Government Medical Colleges and Hospital and the new building of Central Institute of Classical Tamil, Chennai on 12.01.2022 by virtual mode.

4. The Government after careful examination, accept the request of the Director of Medical Education and accord sanction for a sum of Rs.4,24,291 (Rupees Four lakh twenty four thousand two hundred and ninety one only) incurred towards the arrangements for video conferencing equipments with related accessories for the inaugural function of 11 New Government Medical Colleges and Hospital and the new building of Central Institute of Classical Tamil, Chennai on 12.01.2022 by virtual mode.
