### ORDER:

In the letter read above, the Mission Director, State Health Society has stated that the Government of India have transferred and credited into State Government Account its share of Grants-in-Aid for 1<sup>st</sup> Installment of Infrastructure Maintenance under National Health Mission during 2018-19. The details are as follows:-

The corresponding 40% of the State Share against the 60% of the Government of India release Rs.31,33,03,000/- (Rupees Thirty one crore thirty three lakh and three thousand only) works out Rs.20,88,68,667/- (Rupees Twenty crore eighty eight lakh sixty eight thousand six hundred and sixty seven only).

3. The Mission Director, National Health Mission has therefore requested the Government to issue orders for the release of a sum of Rs.20,88,68,667/- (Rupees Twenty Crore Eighty Eight Lakh Sixty Eight Thousand Six Hundred and Sixty Seven Only) towards the State Share of Grants-in-aid for 1<sup>st</sup> Installment of Infrastructure Maintenance during 2018-19 as mentioned above and to authorize him, to draw a sum Rs.20,88,68,667/-

(Rupees Twenty crore eighty eight lakh sixty eight thousand six hundred and sixty seven only) under National Health Mission and credit it into State Health Society Account.

The Government after careful consideration have decided to accept the above proposal of the Mission Director, State Health Society and accordingly sanction a sum of Rs.20,88,68,667/- (Rupees Twenty crore eighty eight lakh sixty eight thousand six hundred and sixty seven only) towards the State Share contribution of Grants-in-Aid for 1<sup>st</sup> Installment Infrastructure Maintenance during 2018-19 under National Health Mission.
