The Government after careful consideration have decided to accept the above proposal of the Mission Director, National Health Mission and accordingly sanction a sum of Rs.347,26,86,667/- (Rupees Three Hundred and Forty Seven Crore Twenty Six Lakh Eighty Six Thousand Six Hundred and Sixty Seven Only) towards the State Share for Liquidation of arrears of 2019-2020 and 2020-2021 for implementation of Infrastructure Maintenance, for the financial year 2021-2022.
