### ORDER:

The Director of Public Health and Preventive Medicine in his letters read above has stated that the Medical Services Recruitment Board has sponsored 2942 candidates for appointment as Assistant Surgeon in Tamil Nadu Medical Service during 2013 to February 2014. Of them, about 362 candidates have not attended the counselling on the specified dates. Hence, compulsory posting orders were issued to the absentees, directing them to join duty within 30 days from the date of receipt of the orders. The names of 371 candidates who have not joined duty have been returned to the Medical Services Recruitment Board requesting to sponsor suitable candidates. Accordingly, the Medical Services Recruitment Board have sponsored 315 candidates as against 371 candidates. He has also informed that certain candidates (including the candidates who opted for postings and not joined duty within the stipulated time granted therein) have now requested for appointment in Tamil Nadu Medical Service seeking extension of joining time as a special case for various reasons viz., doing Post Graduation and family circumstances etc.,

2. There is a dearth of hands in the category of Assistant Surgeon in Tamil Nadu Medical Service, more so in respect of Medical Officers with Post Graduate degree in certain specialities. The list of Medical Officers selected for temporary appointment in Tamil Nadu Medical Service, including Reserve list of candidates, has been exhausted. The individuals in question have expressed their willingness to join in Tamil Nadu Medical Service, the Government have therefore decided to accept the proposal of the Director of

Public Health and Preventive Medicine. Accordingly, the Government issue the following orders:-

- (i) The joining time is extended in favour of the following Medical Officers sponsored by the Medical Services Recruitment Board during 2013-2014 in relaxation of rule 21(a)(i) of the Special Rules for the Tamil Nadu Medical Service:-

- (ii) The Director of Public Health and Preventive Medicine is directed to permit the above Medical Officers to join duty as Assistant Surgeon in Tamil Nadu Medical Service immediately, subject to the conditions that the position relating to the seniority of the above Medical Officers should be specifically mentioned in their appointment order.

In exercise of powers conferred under rule 48 of the General Rules contained in Part II of the Tamil Nadu State and Sub-ordinate Services, the Governor of Tamil Nadu hereby relaxes rule 21(a)(i) of the Special Rules for the Tamil Nadu Medical Service in favour of the above Medical Officers sponsored by the Medical Services Recruitment Board for the year 2013-14, to enable them to join in Tamil Nadu Medical Service.
