ORDER:

The Mission Director, National Health Mission in his letter read above has stated that, the Government of India have sanctioned Grants-in-Aid for National Health Mission in ROP 2019-20. The ROP for 2019-20 had been placed and approved in 37th EC. Now, the Government of India have released Grants-in-Aid for Other Health System for activities covered under National Urban Health Mission –Flexible Pool Programme under National Urban Health Mission programme during 2019-20 and credited into State Government Account as detailed below:-
