ORDER:

The Mission Director, State Health Society, Government of India have informed that transfer of Central funds under the Centrally Sponsored Schemes like National Health Mission through Treasury route as part of the State Plan and requested to provide for Central Share of National Health Mission in the State Budget. In continuation of the letter first read above, Government of India have transferred and credited into State Government account its Grants in Aid towards the Program for Prevention and Control of Leptospirosis in the State of Tamil Nadu for the year 2014-15 as follows:

The Mission Director, State Health Society has further stated that in order to implement the above said programme the Mission Director has requested the Government Orders, for the release of a sum of Rs.10,00,000/- (Rupees Ten lakh only) as Central contribution of Grants in Aid to the State Health Society under

the Program and to authorize the Mission Director, State Health Society and Project Director, Reproductive and Child Health Project, Tamil Nadu, to draw a sum of Rs.10,00,000/- (Rupees Ten lakh only) under the Program for Prevention and Control of Leptospirosis in the State of Tamil Nadu.

3. Further, in the Budget Estimates for the year 2015-16, under Demand No.19 Government have allocated funds under the following head of account newly created for National Health Mission as detailed below:-

(DPC 2211 00 103 UA 09 32) - Rs.873.1468 Crores
 (DPC 2211 00 789 UA 09 30) - Rs.235.1863 Crores
 (DPC 2211 00 796 UA 09 35). – Rs.11.1993 Crores

4. After careful examination, the Government have decided to accept this proposal and accordingly, sanction a sum of Rs. 10,00,000/- (Rupees ten lakh only) being the Central contribution of grants – in – aid to the State Health Society under the Programme for Prevention and Control of Leptospirosis in Tamil Nadu.
