ORDER:

In Government Order first read above, permission was accorded to the Chairman, Cross Trust, Nagercoil, Kanyakumari District to start a School of Nursing in the name and style as "Cross School of Nursing" to conduct Diploma in Nursing course at Nagercoil, with an annual intake of 20 students from the academic year 2007-2008.

2. Further, in Government order second read above, permission was accorded to the Chairman, Cross Trust, Nagercoil, Kanyakumari District to up-grade 20 seats of Diploma in General Nursing and Midwifery Course into B.Sc (Nursing) course and in addition 30 seats of new intake in B.Sc (Nursing) course total by 50 seats at Cross College of Nursing in S.F. No.319/5 at Wattspuram, Therisanam Cope Village, Nagercoil - 629 851 from the academic year 2020-2021.

3. In the reference third read above, the Chairman, Cross Trust, Nagercoil has requested to issue an amendment to G.O (Ms) No.388, Health and Family Welfare (PME2) Department, dated 26.09.2020, to that effect to indicate new additional seats in B.Sc (Nursing) course from 20 to 50 instead of enhancement of seats from 20 to 50 seats as mentioned in the abstract portion of the said Government Order.

4. The Director of Medical Education has also recommended the same and requested the Government to issue necessary amendments to G.O (Ms) No.388, Health and Family Welfare (PME2) Department, dated 26.09.2020 suitably.

5. The Government after careful examination decided to accept the request as mentioned in paragraph 3 above and as recommended by the Director of Medical Education and accordingly issue the following amendment to the Government order second read above:-
