ORDER:

The Mission Director, State Health Society in his letter read above has stated that the Central funds under the Centrally Sponsored Schemes like National Health Mission are routed through the Treasury route as part of the State Plan and requested to provide for Central Share of National Health Mission in the State Budget. The Government of India in their letter 1st read above have transferred and credited a sum of Rs.81,74,000/- (Rupees Eighty one lakh and seventy four thousand only) into State Government account as its 75% share of Grants in Aid for the financial year 2015-16 for implementation of schemes under National Leprosy Eradication Programme during 2015-16 as mentioned below:-

The corresponding 25% of the State Share against the 75% of the Government of India release of Rs.81,74,000/- (Rupees Eighty one lakh and seventy four thousand only) works out to Rs.27,24,666/- (Rupees Twenty seven lakh twenty four thousand six hundred and sixty six only). Since Government of India has transferred the grants to State Government for drawal of amount through Treasury route from 2014-15, the amount of Central Share and State share will have to be drawn from State Budget. The Mission Director, State Health Society has requested the Government orders, for release of a sum of Rs.1,08,98,666/- (Rupees One crore eight lakh ninety eight thousand six hundred and sixty six only) towards release of Central and State contribution of grants in aid of Rs.81,74,000/- (Rupees Eighty one lakh and seventy four thousand only) as 75% Central share and Rs.27,24,666/- (Rupees Twenty seven lakh twenty four thousand six hundred and sixty six only) as 25% State share to the State Health Society under National Leprosy Eradication Programme for the year 2015-16 for implementing the schemes under the above mentioned project and to authorize the Mission Director, State Health Society / Project Director Reproductive and Child Health Project, Tamil Nadu to draw a sum of Rs.1,08,98,666/- (Rupees One crore eight lakh ninety eight thousand six hundred and sixty six only) under National Health Mission through Treasury mode.

3. The Government after careful consideration have decided to accept the above proposal of the Mission Director, State Health Society and accordingly sanction a sum of Rs.1,08,98,666/- (Rupees One crore eight lakh ninety eight thousand six hundred and sixty six only) to the State Health Society, Tamil Nadu for the implementation of Schemes under National Leprosy Eradication Programme in the Tamil Nadu.
