The Mission Director, State Health Society has therefore requested the Government to issue orders for the release of a sum of Rs.249,20,00,000/- (Rupees Two hundred and forty nine crore and twenty lakh only) being the State and Central Share contribution of Grants-in-Aid to the Other Health System activities covered under National Rural Health Mission & Comprehensive Primary Health Care under Health System Strengthening for the year 2018 - 2019 as mentioned above and to authorize him to draw the above amount under National Health Mission through Treasury mode and credit it into State Health Society Account.

The Government after careful consideration has decided to accept the above proposal of the Mission Director, State Health Society and accordingly sanction a sum of Rs.249,20,00,000/- (Rupees Two hundred and forty nine crore and twenty lakh only) being the State and Central Share contribution of Grants-in-Aid to the Other Health System activities covered under National Rural Health Mission & Comprehensive Primary Health Care under Health System Strengthening for the year 2018 – 2019.
