### ORDER:

In the letter read above, the Mission Director, State Health Society has stated that the Government of India have transferred and credited into State Government Account its share towards Release of Grants-in-Aid for Reproductive Child Health Flexible Pool including other Programme during 2018-19 as detailed below:-

2. The corresponding 40% of the State share against the 60% of the Government of India share of Rs. 54,49,00,000/- (Rupees Fifty Four Crore and Forty Nine Lakh only) works out of Rs.36,32,66,667/- (Rupees Thirty Six Crore Thirty Two Lakh Sixty Six Thousand Six Hundred and Sixty Seven Only).

3. The Mission Director, State Health Society has therefore requested the Government to issue orders for the release of a sum of Rs.90,81,66,667/- (Rupees Ninety Crore Eighty One Lakh Sixty Six Thousand Six Hundred and Sixty Seven Only) being the State and Central Share contribution of Grants-in-Aid for Reproductive Child Health Flexible Pool including Other Programme year 2018 - 2019 as mentioned above and to authorize him to draw the above amount under National Health Mission through Treasury mode and credit into State Health Society Account.

4. The Mission Director, State Health Society has also requested the Government to reappropriate a sum of 1 crore from the Head of Account 2211 00 103 UA 09 32 (General) to Head of Account 2211 00 794 UA 09 39 (TSP).

5. The Government after careful consideration has decided to accept the proposal of the Mission Director, State Health Society and accordingly ordered as follows:

- i. A sum of Rs.90,81,66,667/- (Rupees Ninety Crore Eighty One Lakh Sixty Six Thousand Six Hundred and Sixty Seven Only) being the State and Central Share contribution of Grants-in-Aid to the RCH Flexible Pool including other Programme for the year 2018 – 2019 be sanctioned to the Mission Director, State Health Society and he is authorized to draw the above amount under National Health Mission through Treasury mode and credit into State Health Society Account.
- ii. A sum of Rs.94,60,000/- (Rupees Ninety four lakh sixty thousand only) be reappropriated from the Head of Account 2211 00 103 UA 09 03 (General) to Head of Account 2211 00 794 UA 09 -03 (TSP) .

6. The amount sanctioned in para 5 above shall be debited to the following heads of account:-
