### **ORDER:-**

In the Government Order first read above, orders were issued permitting the Director of Public Health and Preventive Medicine to fill up the vacancies in the post of Assistant Surgeon (Speciality) in Tamil Nadu Medical Service, by 'Walk-in' selection process, through the Medical Services Recruitment Board, in every quarter of the year, after due notification in the newspaper, for selecting eligible candidates to fill up the Assistant Surgeon in various Speciality departments in Tamil Nadu Medical Service, duly following the communal rotation and the rule of reservation as per orders in force.

2. In para 5 (ii) of the said Government order, the Director of Public Health and Preventive Medicine was directed to appoint the candidates selected through the 'Walk-in' selection process temporarily in the Tamil Nadu Medical Service, in relaxation of rule 10(a)(i) of the General Rules for the Tamil Nadu State and Subordinate Services Rules and to regularize their services by conducting a Special Qualifying Examination by the Medical Services Recruitment Board.

3. The Chairman, Medical Services Recruitment Board in his letter second read above has requested orders of the Government to the effect that the candidates selected by the Medical Services Recruitment Board for appointment as Assistant Surgeon (Speciality) in Tamil Nadu Medical Service by 'Walk-in' selection process need not write Special Qualifying Examination for regularization of their services.

4. The proposal of the Chairman, Medical Services Recruitment Board was examined in detail. The selection of Assistant Surgeon (Speciality) by 'Walk-in' selection process is by the Medical Services Recruitment Board, the authorized recruiting agency for Tamil Nadu Medical Service, duly following Communal rotation and the Rule of reservation in vogue. Further, the candidates are selected by the Medical Services Recruitment Board based on the marks obtained by them in the Post Graduate Degree / Diploma after thorough scrutiny of mark sheet / relevant records of the candidates.

5. In the circumstances, the Government have decided to accept the proposal of the Chairman, Medical Services Recruitment Board. Accordingly, the Government direct that services of Assistant Surgeon (Speciality) who were appointed in Tamil Nadu Medical Service by 'Walk-in' selection process, through the Medical Services Recruitment Board be regularised with effect from their date of joining duty in Tamil Nadu Medical Service, in relaxation of paragraph 5 (ii) of G.O. (Ms) No. 279, Health and Family Welfare Department dated 15.09.2014, subject to the condition that they should fulfill all other qualifications / criteria prescribed in the Special Rules for Tamil Nadu Medical Service.

6. The Director of Public Health and Preventive Medicine is directed to place these Assistant Surgeon (Speciality) whose services are regularized, below the last batch of Medical Officers recruited through competitive examination conducted by the Medical Services Recruitment Board.

7. This order issues with the concurrence of the Personnel and Administrative Reforms Department vide its U.O No. 14314/C1/2020, dated 15.06.2020.
