ORDER:-

In the letter fifth read above, the Director of Medical Education has stated that in the Government Order first read above, the Government have sanctioned a sum of Rs.78.00 Crore for construction of building for National Centre of Ageing in the premises of King Institute of Preventive Medicine and Research Centre, Guindy, Chennai and in the Government Order second read above revised administrative sanction has been accorded for a sum of Rs.87,99,19,585/- against the original sanction of Rs.78.00 crore and work has been completed in all respect.

2. The Director of Medical Education has further stated that during the meeting conducted by the Dean, Madras Medical College with Public Works Department and the Director, National Centre of Ageing, certain additional works were referred and the estimate amount works out to Rs.04.61 Crore. In the meantime, in the Government Order fourth read above, the Government have released Non-Recurring Grant of Rs.04.61 Crore sanctioned by the Government of India for establishment of National Centre of Ageing in the premises of King Institute of Preventive Medicine and Research Centre, Guindy, Chennai under National Programme for Health Care of Elderly. As per the above orders, the amount of Rs.04.61 crore has been deposited into the Single Nodal Account of the Director of Medical Education maintained for the above scheme. She has also stated that the

Executive Engineer, Public Works Department, Building Construction Division-I, Medical Works, Chennai has forwarded the proposal for Additional Amenities for the work of construction of Building for National Centre of Ageing in the Premises of King Institute of Preventive Medicine and Research, Guindy, Chennai and the estimate amount works out to Rs.04.61 crore for the above work. The following additional amenities for the work of construction of building for National Centre of Ageing in the premises of King Institute of Preventive Medicine and Research, Guindy, Chennai are proposed to be carried out by utilizing the Grant-in-Aid of Rs.04.61 crore released by the Government in the Government Order fourth read above.

The Director of Medical Education has furnished the Revised Detailed Estimate approved by the Engineer-in-Chief and Chief Engineer (General), Public Works Department, Building Construction Division-I, Medical Works, Chennai, duly counter signed by her and requested to accord necessary Administrative sanction for providing Additional Amenities for the work of Construction of Building and others for National Centre of Ageing in the Premises of King Institute of Preventive Medicine and Research, Guindy, Chennai under the National Programme for Health Care Elderly and issue necessary permission and Administrative Sanction to transfer the fund of Rs.04.61 Crore from the Single Nodal Account to Child Account of the Public works Department.

4. The Government, after careful examination, have decided to accept the proposal of the Director of Medical Education and issue the following orders:-

- i) The Director of Medical Education is permitted to carry out Additional Amenities for the construction of buildings for the National Centre of Ageing, in the Premises of King Institute of Preventive Medicine and Research, Guindy, Chennai under the National Programme for Health Care Elderly, as detailed in para 2 above by utilising the sum of Rs.4,60,78,176/- (Rupees

Four crore sixty lakh seventy eight thousand one hundred and seventy six only) released by the Government in the Government Order fourth read above, through the Public Works Department.

- ii) The Director of Medical Education is authorized to draw and disburse the amount sanctioned above from her Single Nodal Account to the Child Account of the Public Works Department and also to furnish the Utilization Certificate to the Government of India at the appropriate time in the prescribed format, as already directed in the above Government Order fourth read above.
