ORDER:

In the circumstances reported by the Project Director, Tamil Nadu Health Systems Project, the following amendment shall be issued to G.O.(Ms.)No.240, Health & Family Welfare (EAP1(1)) Department, dated: 05.06.2020.

Amendment

For the existing para 6(ix) and 6(xiii) in G.O.(Ms.)No.240, Health and Family Welfare (EAP1(1)) Department, dated: 05.06.2020, the following paragraphs shall be substituted.

- 6(ix) An amount of Rs.1500/- is fixed with effect from 16.07.2020 as cost of RT-PCR testing under Chief Minister's Comprehensive Health Insurance Scheme and home visits can be done if the Dean / Superintendent/ Chief Medical Officer certifies that the patient is not in a condition to come to the sampling centre.
- 6(xiii) An amount of Rs.2000/- is fixed as cost of RT-PCR testing for General Public and an amount of Rs.500/- has to be paid as an additional cost towards home visit.

2. In G.O.(Ms.)No.240, Health and Family Welfare (EAP1(1)) Department, dated: 05.06.2020, after para 6(xiv), the following shall be added as para 6(xv):-

6(xv) A base rate of Rs.1000/- is fixed for pooled samples done under Chief Minister's Comprehensive Health Insurance Scheme, for earlier and future samples.
