ORDER:

In the letter read above, the Mission Director, State Health Society has stated that the Government of India have transferred and credited its share into Government of Tamil Nadu account being the Grants-in-Aid for Flexible Pool for Communicable Diseases (NDCPs) for the year 2018-19 as detailed below:-

2. The corresponding 40% of the State share against the 60% of the Government of India share of Rs.32,16,00,000/- (Rupees Thirty two crore and

sixteen lakh only) works out of Rs.21,43,99,999/- (Rupees Twenty one crore forty three lakh ninety nine thousand nine hundred and ninety nine only).

3. The Mission Director, State Health Society has therefore requested the Government to issue orders for the release of a sum of Rs.53,59,99,999/- (Rupees Fifty three crore fifty nine lakh ninety nine thousand nine hundred and ninety nine only) being the State and Central Share contribution of Grants-in-Aid for National Diseases Control Programme(NDCPs) for the year 2018 - 2019 as mentioned above and to authorize him to draw the above amount under National Health Mission through Treasury mode and credit into State Health Society Account.

4. The Mission Director, State Health Society has also requested the Government to re-appropriate a sum of Rs.58,33,333/- from the Head of Account "2211 00 103 UA 09 32" (General) to Head of Account "2211 00 794 UA 09 39" (STSP).

5. The Government after careful consideration has decided to accept the above proposal of the Mission Director, State Health Society and accordingly (i) sanction a sum of Rs.53,59,99,999/- (Rupees Fifty three crore fifty nine lakh ninety nine thousand nine hundred and ninety nine only) being the State and Central Share contribution of Grants-in-Aid for National Diseases Control Programme (NDCPs) under National Rural Health Mission for the year 2018 – 2019. (ii) A sum of Rs.58,33,333/- (Rupees Fifty eight lakh thirty three thousand three hundred and thirty three only) be re-appropriated from the Head of Account 2211 00 103 UA 09 32 (General) to Head of Account 2211 00 794 UA 09 39 (ST).

6. The amount sanctioned in para 5 above shall be debited to the following heads of account:-

8. The Mission Director, State Health Society / Project Director, Reproductive and Child Health Project, Tamil Nadu is authorized to draw the amount sanctioned in para 5 above and to credit into State Health Society Account.
