ORDER:

The Mission Director, National Health Mission in his letter read above has stated that, the Government of India have released Grants-in-aid for Reproductive and Child Health Flexible Pool during 2020-2021 and credited into State Government account for drawal of amount through treasury as detailed below:-

The corresponding 40% of the State share against the 60% of the Government of India share of Rs.93,91,00,000/- (Rupees Ninety Three Crore and Ninety One Lakh only) works out to Rs.62,60,66,667/- (Rupees Sixty Two Crore Sixty Lakh Sixty Six Thousand Six Hundred and Sixty Seven only).

2. The Mission Director, National Health Mission has therefore requested the Government to release a sum of Rs.156,51,66,667/- (Rupees One Hundred and Fifty Six Crore Fifty One Lakh Sixty Six Thousand Six Hundred and Sixty Seven only) towards the State and Central Share contribution of Grants-in-Aid for Reproductive and Child Health Flexible Pool during the year 2020-21 and to authorize him to draw the above amount under National Health Mission through treasury mode and credit into National Health Mission Account.

3. The Government after careful consideration have decided to accept the above proposal of the Mission Director, National Health Mission and accordingly sanction a sum of Rs.156,51,66,667/- (Rupees One Hundred and Fifty Six Crore Fifty One Lakh Sixty Six Thousand Six Hundred and Sixty Seven only (State share Rs.62,60,66,667/- and Government of India share – Rs.93,91,00,000/-) for the Reproductive and Child Health Flexible Pool during the year 2020-2021.
