The Mission Director, National Health Mission in his letter read above has stated that, the Government of India have released Grants-in-aid for Other Health System for activities covered under National Rural Health Mission during 2020-2021 and credited into State Government account for drawal of amount through treasury as detailed below:-

The corresponding 40% of the State share against the 60% of the Government of India share of Rs.140,30,00,000/- (Rupees One Hundred and Forty Crore and Thirty Lakh only) works out to Rs.93,53,33,333/- (Rupees Ninety Three Crore Fifty Three Lakh Thirty Three Thousand Three Hundred and Thirty Three only).

2. The Mission Director, National Health Mission has therefore requested the Government to release of a sum of Rs.233,83,33,333/- (Rupees Two Hundred and Thirty Three Crore Eighty Three Lakh Thirty Three Thousand Three Hundred and Thirty Three only) towards the State and Central Share contribution of Grants-in-Aid for Other Health System for activities covered under National Rural Health Mission during the year 2020-21 and to authorize him to draw the above amount under National Health Mission through Treasury mode and credit into National Health Mission Account.

The Government after careful consideration have decided to accept the above proposal of the Mission Director, National Health Mission and accordingly sanction a sum of Rs.233,83,33,333/- (Rupees Two Hundred and Thirty Three Crore Eighty Three Lakh Thirty Three Thousand Three Hundred and Thirty Three only) towards the State and Central Share contribution (State share Rs.93,53,33,333/- and Government of India share - Rs.140,30,00,000/-) towards Other Health System activities covered under National Rural Health Mission during the year 2020-2021.
