



## **ABSTRACT**

State Health Society – Tamil Nadu – National Health Mission – Revision of consolidated pay for the post of Audiologist for the ongoing scheme of National Programme for Prevention and Control of Deafness (NPPCD) – Permitted - Orders – Issued.

### **ORDER:**

In Government order first read above, orders have been issued to place 31 post of Audiologist at one per District with the consolidated pay of Rs.9000/- per month through outsourcing for the ongoing scheme of National Programme for Prevention and Control of Deafness (NPPCD).

2. It is submitted that National Programme for Prevention and Control of Deafness Programme is being implemented in a phased manner since 2008 under National Health Mission as detailed below:-

Pilot Phase	Vellore, Villupuram and Thanjavur Districts (3)
Phase 1	Coimbatore, Cuddalore, Dharmapuri, Dindigul, Erode, Madurai, Nagapattinam, Namakkal, Pudukottai, Ramanathapuram, Salem, The Nilgiris, Tiruvarur, Trichy, Tirunelveli and Tiruvannamalai (16)
Phase 2	Kancheepuram, Kanyakumari, Karur, Krishnagiri, Perambalur, Sivagangai, Thoothukudi, Theni, Virudhunagar and Thiruvallur (10)
Phase 3	Thiruppur and Ariyalur (2)

3. The Mission Director, National Health Mission has stated that the above programme has to be implemented with the following provisions:-

- a) Infrastructural Development
- b) Recruitment of exclusive HR for National Programme for Prevention and Control of Deafness
- c) Capacity building of Institutions holding National Programme for Prevention and Control of Deafness corners including support for manpower and training
- d) Supply ENT equipment and Kits.

4. In the letter second read above, the Mission Director, State Health Society has also stated that in the Record of Proceedings 2017-18, the Government of India had approved Rs.6.20 lakh towards the salary cost for 31 posts of Audiologist at the rate of one per district with salary of Rs.20,000/- per month for 1 month.

5. The Mission Director, State Health Society has also stated that as on 31<sup>st</sup> December 2017, the above 31 posts of Audiologist has been kept vacant due to difficulty in getting qualified hands for low consolidated pay of Rs.9,000/- per month. Hence he has proposed for revision of pay from Rs.9000/- per month to Rs.20,000/- per month as approved in Record of Proceedings 2017-18. The above proposal has been approved by the Executive sub Committee of State Health Society and the same has been adopted by the 34<sup>th</sup> Executive Committee meeting vide agenda no 5.

6. The Mission Director, State Health Society has therefore requested Government orders in this regard.

7. After careful examination, the Government have decided to accept the proposal of Mission Director, State Health Society and accordingly issue the following orders:-

- i. The Mission Director, State Health Society is permitted to revise the consolidated pay of 31 posts of Audiologist sanctioned in the Government Order first read above, from Rs.9000/- per month to Rs.20,000/- per month with 5% annual increment.
- ii. The Mission Director, State Health Society is permitted to release the salary cost to the districts under National Programme for Prevention and Control of Deafness(NPPCD) funds after filling up of the above posts through outsourcing.

8. This order issues with the concurrence of the Finance Department vide its U.O. No.29342/Health I/18, dated: 16.07.2018.
