ORDER:

Tamil Nadu State Illness Assistance Society, Chennai-6 is a Central – State Shared scheme at the ratio of 1:2 sanctioning financial assistance to the Below Poverty Line People, suffering from life threatening diseases.

2. The Director of Medical and Rural Health Services has stated that a sum of Rs.5.00 crores has been provided in Budget Estimate 2014 -2015, to the Tamil Nadu State Illness Assistance Society, being the State Government share under the Head of Account "2210-06-800 UA 09.03 Grants for specific schemes. He has also stated that the funds position of the Tamil Nadu State Illness Assistance Society, Chennai-6 is only Rs.2,33,26,340/- (Rupees Two Crores Thirty Three Lakhs Twenty Six Thousand Three Hundred and Forty only) as on 03.06.2014.

3. The Director of Medical and Rural Health Services has further stated that the Revolving fund have to be recouped as and when they send utilization certificate. The anticipated expenditure is as follows:-

4. The Director of Medical and Rural Health Services has also mentioned that a proposal with regard to the inclusion of more diseases / surgeries under Illness Society under Agenda No.10, the Annual General Body in its 18th Meeting held on 23.12.2013 considered that out of 7 types of surgeries / treatment suggested vide Director of Medical and Rural Health Services

Ref.No.26479/P&D.3/TNSIAS, dated.22.05.13 the following was considered for inclusion under Illness Society apart from the existing 12 types of Surgeries / treatment.

- i) NEPHROLOGY
 - Nephrectomy
 - Dialysis
- ii) OPHTHALMOLOGY
 - Surgery and other procedures
 - Surgery for Glaucoma etc.
- iii) VASCULAR SURGERY
 - Amputation of legs arms toes and foot
- iv) GASTROENTEROLOGY
 - Surgeries of Gall Bladder
 - Liver and pancreas
 - Laparoscopic choleystromy
- v) GYNAECOLOGY
 - Surgical removal of Uterus and ovaries for malignancies
- vi) THORACIC
 - Surgery for lung abscess
 - Pleural effusion and thyroid surgery

A maximum of Rs.25,000/- is being offered as Financial Assistance under this Society. The above amount was fixed during 2002 and the patients are spending lakhs of Rupees towards drugs and consumable and post operative medicines at private hospitals.

5. The Director of Medical and Rural Health Services has also informed that a sum of Rs.63,44,527/- have to be released to the Dean, Government Stanley Hospital, Chennai -1, to settle payment to companies which will be released step by step restricting to the Revolving Fund, after obtaining utilization certificate.

6. The Director of Medical and Rural Health Services has sent the details of beneficiaries as received from the District Collectors and Government Medical College Hospitals and the statement of Receipt and Expenditure for the financial

year from 01.04.2013 to 31.03.2014 to the Government. He has stated that during the financial year 2013-14, the Government have accorded sanction of Rs.2.00 crores, vide G.O.(Ms) No.58, Health, dated.26.2.2014 out of Rs.5 crores provided in Budget Estimate 2013-2014. He has forwarded the statement of Receipt and Expenditure for the last financial year i.e. from 01.04.2013 to 31.03.2014.

7. The Director of Medical and Rural Health Services has requested the Government to accord permission to draw a sum of Rs.5.00 crores provided in Budget Estimate 2014-2015 to credit the sum in P.D. Account No.11443284168 (PD Account No.7070) of the Tamil Nadu State Illness Assistance Society, Chennai-6, being maintained at State Bank of India (Treasury Branch) Thousand Lights, Chennai 9.

8. The Government after careful consideration of the request of the Director of Medical and Rural Health Services accordingly sanction a sum of Rs.2.00 Crores (Rupees Two crores only) to the Tamil Nadu State Illness Assistance Society, being the State Government share so as to credit the same into the PD account of Tamil Nadu State Illness Assistance Society, Chennai-6.

9. The amount sanctioned in para 3 above shall be debited to the following head of account:-

10. The amount sanctioned in para 3 above shall be credited to the following Personal Deposit head of account:-
