ORDER:

In the Government Orders first and second read above, orders have been issued for the implementation of Chief Minister's Comprehensive Health Insurance Scheme for a period of 4 years and extendable for one more year, subject to renewal of contract on yearly basis based on performance and Insurance Regulatory and Development Authority (IRDA) Licence renewal. The said scheme was inaugurated with effect from 11.01.2012.

2. In the Government Order third read above, orders have been issued for the extension of the scheme for one more year from 11.01.2016 to 10.01.2017 as per the existing terms and conditions.

3. In the Government Order fourth read above, among others orders were issued continuing the Chief Minister's Comprehensive Health Insurance Scheme from 11.01.2017.

4. In Government Order fifth read above, the Project Director, Tamil Nadu Health Systems Project was permitted to award tender to United India Insurance Company, who quoted the lowest premium of Rs. 699/- per annum per family. In the new tender 1027 procedures were approved. Based on the meeting with Director of Medical Education /Director of Medical and Rural Health Services and Deans from 3 Medical Colleges, the procedures to be reserved for Government Hospitals was finalized, from the list furnished by the Director of Medical Education / United India Insurance Company. The Project Director has proposed 84 procedures to be reserved for Government Hospitals, from the entire list of 1027 procedures and the rest to be decided later.

5. As per the guidelines of tender document, the Project Director, Tamil Nadu Health Systems Project reserves the right to reserve certain procedures for the Government Hospitals which is a tentative illustrative list. This list can be modified at any time by Tamil Nadu Health Systems Project, in consultation with Health Directorates and approval of Government.

6. The Government have carefully examined the proposal of the Project Director, Tamil Nadu Health Systems Project and decided to accept and reserve the 84 procedures annexed to this Government Order for Government Hospitals, from the list of 1027 procedures approved under Chief Minister's Comprehensive Health Insurance Scheme.


