ORDER:

In the G.O. first read above, orders were issued for recognizing the Sagayamatha Hospital, Pullambadi, Tiruchirapalli as training Centre for Auxiliary Nurse Midwives with an annual intake of fifteen candidates without extra expenditure to the Government. In the letter 2nd read above, the Principal, Sagayamatha Multipurpose Health Worker (Female) Training School, Tiruchirapalli amongothers has requested the Government to grant permission to enhance the number of seats from 15 to 30 from the year 2014-2015 onwards. In this regard, the Director of Public Health and Preventive Medicine has sent the inspection report and recommended for enhancement of seats in the letter 3rd read above.

After the detailed examination the Government have decided to accept the recommendation of Director of Public Health and Preventive Medicine and to accord permission to enhance the number of seats in respect of Auxiliary Nurse Midwives course by Sagayamatha Multi Purpose Health Worker (Female) training

School, Tiruchirapalli from 15 (fifteen) to 30 (thirty) from the academic year 2014-15, without extra any expenditure to the Government.
