ORDER :

The Director of Medical Education in his letter read above has stated that at present there is only one Government Dental College in the State of Tamil Nadu i.e., Tamil Nadu Government Dental College, Chennai and no Government Dental College is located in the southern districts. In order to cater the need of the southern people of Tamil Nadu establishment of a new Government Dental College and Hospital in the campus of Government Medical College & Hospital, Pudukottai is essential considering the growing demand of the meritorious students of the State for the Professional Dental Courses and to suggest that to start a new Government Dental College at Pudukottai District with an annual intake of 50 BDS students from the academic year 2021-2022 and also to create one new post of Special Officer cum Principal for the proposed Government Dental College at Pudukottai, is very essential.

2. The Director of Medical Education has also stated at present the 100 seats in Government Dental College, Chennai are not sufficient to cater the need of the State of Tamil Nadu with its population of 8 Crore. Moreover, there is a skewed distribution of private and Government dental institution in the State and as per the directive of the State policy the establishment of dental institution in Government Sector should be encouraged more and more institution in Government sector should be established so as to cater the need of the student who are meritorious but belong to poor family and are not able to bear the fee of the private dental colleges.

3. The Government after considering the growing demand of meritorious students of the State for Professional Dental Courses, have decided to start a new Government Dental College at Pudukottai District from the academic year 2021-2022.

4. Accordingly, the Government hereby issue the following orders:

- (i) Administrative sanction is accorded for the establishment of a new Government Dental College at Mullur Village in survey No.789/19 with total area of 10.14 acres in the campus of Government Medical College and Hospital, Pudukottai District with an annual intake of 50 BDS students from the academic year 2021-2022.
- (ii) Sanction is also accorded for creation of one post of Special Officer cum Principal in the scale of pay of Rs.1,23,100 – 2,15,900 [Level-28] with applicable allowances to attend the initial work relating to the establishment of new Government Dental College and Hospital at Pudukottai.
- (iii) Orders in respect of land, building, hospital equipments, furniture and staff, etc. will be issued as per the requirement of Dental Council of India separately.

5. The Director of Medical Education is also directed to take appropriate action to assess the requirements of necessary infrastructure such as land, building, equipments, furniture, staff, etc., and send necessary proposal to the Government at the earliest.
