### ORDER:

In the Government order first read above, orders were issued for the establishment of new Government Dental College in Pudukottai District, with an annual intake of 50 BDS seats.

- 2. In his letter second read above, the Director of Medical Education has requested the Government to sanction a sum of Rs.3,65,800/- (Rupees Three lakhs sixty five thousand and eight hundred only) from the Personal Deposit account of the Director of Medical Education, maintained by the Secretary, Selection Committee, for payment of Affiliation fees to The Tamil Nadu Dr.MGR. Medical University, Chennai-32.
- 3. The Government examined the proposal of the Director of Medical Education carefully and accordingly, the Government permit the Director of Medical Education to incur an expenditure of Rs.3,65,800/- (Rupees Three lakhs sixty five thousand and eight hundred only) from the Personal Deposit account of the Director of Medical Education, maintained by the Secretary, Selection Committee, for payment of Affiliation fees to The Tamil Nadu Dr.MGR. Medical University, Chennai-32.
- 4. The Director of Medical Education is directed to incur the above expenditure initially from the Personal Deposit account of the Director of Medical Education being maintained by the Additional Director of Medical Education / Secretary, Selection Committee and reimburse it after obtaining Budget allotment, without fail.
- 5. The Director of Medical Education is directed to instruct the Principal of the Government Dental College, Pudukottai to include the expenditure in the Revised Estimate / Final Modified Appropriation, 2020-2021 so as to reimburse the spent amount into the Personal Deposit account of Director of Medical Education.

6. The Director of Medical Education is directed to take necessary action accordingly.
