ORDERS:

In the Government Order first read above, Orders have been issued for the constitution of Medical Services Recruitment Board, so as to centralize the mode of direct recruitment to all categories of posts in the Health and Family Welfare Department. In the Government Order second read above, Rules of Procedure of Medical Services Recruitment Board for recruitment to various categories of posts have been issued and recruitments are done, as per the selection procedure prescribed in Government Order third read above duly following the 200 point Roaster as per the G.O.(Ms).No.65, Personal and Administrative Reforms Department, dated: 27.05.2009 and by following the existing rules of reservation in various appointments.

2. The Chairman, Medical Services Recruitment Board in his letter eight read above has stated that in the Government Order fourth read above, orders were issued reserving 3% of vacancies for the Differently abled persons. Further in the Government Order fifth read above, the Government have ordered that 3% of the quota reserved for

the differently abled persons should be made applicable in respect of Group C and D categories of Posts and out of 3% reservation for differently abled, 1% is reserved for visually challenged, 1% for hearing impaired / deaf and 1% for orthopaedically challenged. In Government Orders sixth and seventh read above, the Government have identified and reserved certain posts for Differently abled persons in Group A and B Categories in direct recruitment.

3. The Chairman, Medical Services Recruitment Board has also stated that, to fill up the paramedical posts by the Medical Services Recruitment Board, it is necessary to specify the suitability for various C and D posts, to persons with disabilities. In order to ascertain suitability of the differently abled persons, a discussion was held with the Heads of Department of Health and Family Welfare Department, and 42 posts were identified under Group C Category in Health and Family Welfare Department for suitability of the differently abled persons. The Chairman, Medical Services Recruitment Board has therefore requested to issue specific orders to extend 3% reservation for direct recruitment to various para-medical posts in Group C category of posts.

4. In the letter ninth read above, the State Commissioner for the Differently Abled has also requested to issue specific orders regarding notification of suitability of persons for various C category posts.

5. The Government have examined the proposal of the Chairman, Medical Services Recruitment Board carefully and decided to accept it. Accordingly, the Government approve the suitability of posts in Direct Recruitment of Differently abled persons to various Paramedical posts in Group C Category as Annexed to the Government Order.

6. This order issues with the concurrence of Welfare of Differently Abled Persons Department vide its U.O. No.14825/DAP3-2/2015-2, dated: 17.12.2015.
