ORDER:

In the G.O first read above administrative sanction was accorded for the implementation of Tamil Nadu Urban Healthcare Project at a cost of Rs.1634,69,50,000/- with the assistance of Japanese International Co-operation Agency (JICA). The Project Director Tamil Nadu Urban Healthcare Project was permitted to establish Tamil Nadu Urban Health Care Society to implement the project in 21 Urban Towns/ Cities in 17 Districts of Tamil Nadu.

2. In the G.O second read above, sanction was accorded for the creation of Project Management Unit for Tamil Nadu Urban Healthcare Project. The Tamil Nadu Urban Healthcare Project is mainly procurement and disbursement oriented project. The Project Director, Tamil Nadu Urban Healthcare Project has stated that while implementing the project activities as per the Government orders, the following difficulties from the project side are noticed.

- (a) The civil work and equipment procurement are to be looked after by one officer who is designated as Lead Procurement Manager in Deputy Director rank which is a junior post. As this officer has to work out the requirement of the equipment and to discuss with senior officers in the districts and in Medical Colleges like Joint Directors and Deans etc., on equipment and civil work it is better that post is occupied by a senior level Medical Officer.
- (b) The financial management cell is provided with 2 posts of Accounts Officers and one post of Assistant Accounts Officer. Because of the strict disbursement procedures of Japan International Cooperation Agency the services of two more Accounts Officers are necessary.

- (c) It is also found that two more posts of ministerial Assistants and two posts of Data Entry Operators are required in addition to the already sanctioned four posts for ministerial Assistants and 6 posts of Data Entry Operators / Computer Operators.

3. The following proposal was therefore placed before the State Empowered Committee for approval

- (i) The post of Lead Procurement Manager in Deputy Director rank sanctioned in the above G.O. under Procurement and Engineering cell in the pay scale of 15600 – 39100 + 6600 GP may be upgraded to the rank of Deputy Director / Joint Director in the pay scale of pay band IV for Chief Civil Surgeons / Joint Directors of Health Services (i.e.,) 37400-67000+8700 GP
- (ii) Two posts of Accounts Officers may be temporarily sanctioned on contract for the Project Management Unit during the project period to be filled up on contract by the Project Director at a contract payment of Rs. 30,000 per month either out of retired Government officials from Treasury and Accounts department or through outsourcing of suitable candidates with required qualification in Accountancy.
- (iii) Two posts of Data Entry Operators may be temporarily sanctioned on contract for the Project Management Unit during the project period to be hired from outsourcing agency on contract by the Project Director on a contract payment as per District Collector's rate for Computer Operators.
- (iv) Four posts of ministerial Assistants may be temporarily sanctioned for the Project Management Unit during the project period to be contracted from retired Government officials or through outsourcing agency by the Project Director on contract basis (as per the rates given in Para 5 below.)

4. The State Empowered Committee has approved the above proposal.

5. In this regard, it is stated that in G.O 3rd read above, orders have been issued for upgrading the post of Lead Procurement Manager sanctioned to procurement and Engineering Cell under Tamil Nadu Urban Health Care Project in the pre revised pay scale of Rs.15600 – 39100 + 6600 as Deputy Director in the pay of Rs.123100/- (Level -28, 123100-215900) or Joint Director in the pay of Rs.123100/- (Level-28, 123100-215900).

6. The filling up of posts in Project Management Unit is an approved activity and funds are available under administrative cost of the society. The Executive Committee and the Project Steering Committee of the project have approved and recommended the proposal.

7. The contract payment for the contract posts sanctioned for the Project Management Unit is reimbursable by Japan International Cooperation Agency (JICA) under the JICA part of the project cost. The newly sanctioned contract posts need to be included in the reimbursable list.

8. The Project Director, Tamil Nadu Urban Healthcare Project has therefore requested Government Orders in this regard.

9. The Government after careful examination have decided to accept the proposal of the Project Director, Tamil Nadu Urban Healthcare Project and order as follows:-

- i. Sanction is accorded for the creation of two posts of Accounts Officers to the Project Management Unit to be filled upon contract by the Project Director on contract payment of Rs. 30,000 per month, either out of retired Government servants or through outsourcing with suitable qualification in Accountancy
- ii. Sanction is also accorded for the creation of four posts of ministerial Assistants and two posts of Data Entry Operators temporarily for the Project Management Unit to be outsourced on contract by the Project Director on a contract payment as per the rates now paid for Assistants and Computer Operators in the project respectively.
- iii. The Project Director is permitted to fill up these newly sanctioned contract posts through outsourcing or by employing suitable retired Government employees satisfying the qualifications prescribed.
