#### **ORDER:**

In Government order first read above, permission was accorded to the Managing Trustee, Thandapani Pillai and Sons Educational and Charitable Trust, Nagapattinam to start two years Diploma in Medical Laboratory Technology course with an annual intake of 15 students at Sir Issac Newton Paramedical Institute, Pappakovil Village, Anthanapettai (Post), Nagapattinam District from the academic year 2018-2019.

The Chairman, Thandapani Pillai and Sons Educational and Charitable Trust, Nagapattinam District has requested the Government to enhance the seats in Diploma in Medical Laboratory Technology course at Sir Issac Newton Paramedical Institute, Pappakoil, Anthanapettai Post, Nagapattinam District from the academic year 2019-2020.

3. In the Government letter second read above, the Director of Medical Education was requested to conduct an inspection on the premises of the said institution as per the norms and to furnish their recommendations.

4. In his letter third read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government and recommended to grant permission to the Thandapani Pillai and Sons Educational and Charitable Trust, Nagapattinam District to enhance the seats in Diploma in Medical Laboratory Technology course from 15 to 30 at Sir Issac Newton Paramedical Institute, Pappakoil, Anthanapettai Post, Nagapattinam District from the academic year 2020-2021.

The Government examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and grant permission to the Chairman, Thandapani Pillai and Sons Educational and Chairtable Trust, Nagapattinam District to enhance the Diploma in Medical Laboratory Technology (DMLT) course from 15 to 30 seats (fifteen to thirty) at Sir Issac Newton Paramedical Institute" in R.S.No.47/1, Pappakovil Village, Nagapattinam District – 611 102 from the academic year 2020-2021, subject to the condition that the Trust should obtain the building plan approval from the Directorate of Town and Country Planning for the proposed paramedical institution before admitting the students.
