ORDER:

In Government Order fourth read above, permission was accorded to the Registrar (Academic i/c) Meenakshi Academy of Higher Education and Research (Maher), Chennai to start a College of Nursing in the name and style as "Arulmigu Meenakshi College of Nursing" to conduct B.Sc (Nursing) course at Enathur, Kancheepuram District with an annual intake of 50 students from the academic year 2007-2008.

2. The Vice Chancellor, Meenakshi Academy of Higher Education and Research, Chennai has requested the Government to grant permission to enhance the seats in B.Sc (Nursing) Course from 50 to 100 from the academic year 2020-2021 at Arulmigu Meenakshi College of Nursing, Enathur, Kanchipuram.

3. In Government letter eighth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first to third and fifth to seventh read above and as per the norms of the Indian Nursing Council, New Delhi.

4. In his letter ninth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi and recommended to grant permission to the Vice Chancellor, Meenakshi Academy of Higher Education and Research, Chennai to enhance the seats in B.Sc (Nursing) course from 50 to 100 at Arulmigu Meenakshi College of Nursing, Enathur, Kanchipuram from the academic year 2020-2021.

5. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and grant permission to the Vice Chancellor, Meenakshi Academy of Higher Education and Research, Chennai to enhance the seats in B.Sc Nursing course from 50 to 100 (fifty to hundred) at Arulmigu Meenakshi College of Nursing in S.F. No.609/1, 609/2, Enathur Village, Kanchipuram District-600 078 in the Meenakshi Medical College Hospital and Research Institute building campus from the academic year 2020-2021, subject to fulfilling the specific conditions along with other general conditions laid down in G.O (Ms) No.219, Health and Family Welfare (PME.2) Department, dated: 06.06.2018 as applicable to this proposal before admitting the students.

- i. The Trust should construct the second floor of the academic block to within a period of six months as mentioned in the undertaking submitted by the Chancellor.
- ii. The Trust should obtain recognition from the Tamil Nadu Nurses and Midwives Council, Chennai and if needed, suitability from Indian Nursing Council, New Delhi, respectively.

6. The Director of Medical Education is directed to take necessary further action accordingly.
