Tamil Nadu Medical Service – Appointment of 191 Non Service Post Graduates (Higher Speciality) temporarily on contract basis for a period of three months on a consolidated pay of Rs.90,000/- per month / per head to manage the COVID-19 in-patients in Government Medical College Institutions – Orders – Issued.

From the Director of Medical Education, Letter Ref.No.41452/P&D/3/2/2020, dated 14.08.2020 and 18.08.2020.

ORDER:-

The Director of Medical Education has stated that due to the rapid increase of the Pandemic Covid-19, additional number of doctors are essentially needed to treat the Covid – 19 patients admitted in Government Medical Institutions and in the specially established COVID Centres. He has further stated that 47 Non Service (Higher Speciality) Post Graduates who pursued PG Course in Government Medical Institutions of the 2016-2019 Batch and 144 such candidates in the 2017-2020 Batch who have executed a bond to serve the Government, have not yet been appointed.

2. The Director of Medical Education has, therefore, requested appointment of the above said 191 (144+47) non-service candidates who pursued Post Graduate (Higher Speciality) courses in Government Medical Colleges temporarily on contract basis for a period of 3 months, on a consolidated pay of Rs.90,000/- (Rupees Ninety Thousand only) per month / per head in the following Government Medical Institutions:-

The total Expenditure towards consolidated payment for 3 months is Rs.5,15,70,000/- (Rupees five crores fifteen lakhs and seventy thousand only).

3. The Government have examined the request of the Director of Medical Education. The Non Service Post Graduates (Higher Speciality) who pursue the course in Tamil Nadu Government Medical Colleges execute a bond to work in Tamil Nadu Medical Service compulsorily, for a period of 2 years and they are generally appointed against regular vacancies. However, in the present pandemic situation the Director of Medical Education has proposed to utilize their services by appointing them in Government Medical Institutions temporarily on contract basis on a consolidated pay.

4. The Government accept the proposal of the Director of Medical Education and accord permission to appoint 191 Non Service Post Graduates (Higher Speciality) who pursued the course in Tamil Nadu Government Medical Institutions (47 candidates of 2016-2019 Batch and 144 candidates of 2017-2020 Batch), temporarily on contract basis for a period of 3 months on a consolidated pay of Rs.90, 000/- per month / per head in the Government Medical Institutions mentioned in para 2 above and sanction a sum of Rs.5,15,70,000/- (Rupees five crores fifteen lakhs and seventy thousand only) towards consolidated pay for the above appointment.

5. The expenditure sanctioned in para 3 above shall be debited to the following Head of Account:-

6. Necessary additional funds of Rs.5,15,70,000/- will be provided in the RE / FMA 2020-21. Pending provision of such funds in RE/FMA 2020-21, the Director of Medical Education is authorized to draw and disburse the amount sanctioned in para 4 above. However, this expenditure shall be brought to the notice of the legislature by Specific inclusion in the Supplementary Estimates 2020-21. The Director of Medical Education is also requested to include this expenditure while sending the budget proposals for RE / FMA 2020-21 and draft explanatory notes for Supplementary Estimates 2020-21 to Government in Finance (BG-1 / Health II) Department without fail.

7. This order issues with the concurrence of Finance Department vide its U.O.No.33522/H-II/2020, dated 16.10.2020 and Additional Sanction Ledger No.714 (Seven Hundred and Fourteen).
