ORDER:

In the letter read above, the Mission Director, State Health Society has stated that the Government of India have transferred and credited into State Government Account its share towards Release of Grants-in-aid for National Disease Control Programme Flexible Pool Programme during 2018-19 as detailed below:-

2. The corresponding 40% of the State share against the 60% of the Government of India share of Rs.7,96,00,000/- (Rupees Seven crore and ninety six lakh only) works out of Rs.5,30,66,667/- (Rupees Five crore thirty lakh sixty six thousand six hundred and sixty seven only).

The Mission Director, State Health Society has therefore requested the Government to issue orders for the release of a sum of Rs.13,26,66,667/- (Rupees Thirteen crore twenty six lakh sixty six thousand six hundred and sixty seven only) being the State and Central Share contribution of Grants-in-Aid for National Diseases Control Programme (NDCPs) during 2018-19 as mentioned above and to authorize him to draw the above amount under National Health Mission through Treasury mode and credit it into State Health Society Account.

The Government after careful consideration have decided to accept the proposal of the Mission Director, State Health Society and accordingly sanction a sum of Rs. 13,26,66,667/- (Rupees Thirteen crore twenty six lakh sixty six thousand six hundred and sixty seven only) being the State and Central Share contribution of Grants-in-Aid for National Diseases Control Programme (NDCPs) for the year 2018 - 2019 and to authorize him to draw the above amount under National Rural Health Mission through Treasury mode and credit into State Health Society Account.
