### **ORDER:-**

In the Government order first read above, orders were issued permitting the Director of Medical Education to appoint of 574 Non Service Post Graduates who pursued the course in Tamil Nadu Government Medical Institutions, temporarily on contract basis for a period of 3 months with consolidated pay of Rs. 75,000/-pm/per head, in the 37 Government Medical Institutions and sanctioned a sum of Rs.12,91,50,000/- (Rupees twelve crore ninety one lakh and fifty thousand only) towards consolidate payment for the above appointment.

2. In the letter 2<sup>nd</sup> read above, the Director of Medical Education has stated that based on the above Government Order, necessary appointment and posting orders have been issued to the Non Service Post Graduates and they are working in Government Medical College Hospitals and Covid Centres in Chennai, Chengalpattu and Thiruvallur Districts. The Services of Non Service Medical Officers are very much required for additional three months period from Sep. 2020 to Nov. '2020 since the admission of Covid – 19 patients in Government Medical College Hospitals are increasing day by day.

3. The Director of Medical Education, has, therefore, requested the Government to issue necessary orders to utilize the services of Non Service Post Graduates - 2020 for a further period of 3 months from Sep. 2020 to Nov. '2020 and sanction of Rs.12,91,50,000/- (Rupees twelve crore ninety one lakh and fifty thousand only) towards consolidated payment for the above extension period.

4. The Government have examined the request of the Director of Medical Education and have decided to accept the same. Accordingly, the Government accord permission to the Director of Medical Education to utilize the services of 574 Non Service Post Graduates who were temporarily appointed in the G.O. first read above for a further period of 3 months from September 2020 to November 2020 on contract basis with consolidated pay of Rs.75,000/- pm/per head, in 37 Government Medical Institutions and sanction a sum of Rs.12,91,50,000/- (Rupees twelve crore ninety one lakh and fifty thousand only) towards consolidated payment for the above appointment.

5. The amount sanctioned in para 4 above, shall be debited to the following Head of Account:-

6. Necessary additional funds of Rs.12,91,50,000/- will be provided in the RE/FMA 2020-21, pending provision of such funds in the RE/FMA 2020-21, the Director of Medical Education is authorized to draw and disburse the amount sanctioned in para 4 above. However, this expenditure shall be brought to the notice of the legislature by Specific Inclusion in the Supplementary Estimates 2020-21. The Director of Medical Education is also directed to include this expenditure while sending the budget proposals for RE/FMA 2020-21 and draft explanatory notes for Supplementary Estimates 2020-21 to Government in Finance (BG-II /Health-II) Department without fail at an appropriate time.

7. This order issues with the concurrence of Finance Department vide its U.O.No.35328/Health-II/2020, dated 19.10.2020 and Additional Sanction Ledger No.731 (Seven Hundred and Thirty One).
