### **ORDER :**

In the Government order first read above, the Government have granted permission to the Dean, Madras Medical College, Chennai, to start two year Post Doctoral Fellowship Programme in Minimal Access Surgery at Madras Medical College, Chennai, from the year 2014-2015 with an annual intake of two seats subject to certain conditions.

2. The Director of Medical Education in her letter 2<sup>nd</sup> read above has requested certain amendment to the Government Order 1<sup>st</sup> read above.

3. The Government, after careful examination, have decided to accept the proposal of the Director of Medical Education and issue the following amendments to the Government Order 1<sup>st</sup> read above

### **AMENDMENT**

- i) For the existing para 3 (vi) the following shall be substituted:-

“(vi) The service candidates shall be paid salary as per rules in force i.e. only to claim Pay + DA on par with service candidates opting for Diploma, Specialty and Super Specialty Courses since other allowances are not admissible and the Non-Service candidates shall be paid stipend as per the rules in force.”

- ii) For the existing para 3 (vii) the following shall be substituted:-

“(vii) The service candidates shall be relieved from where he/she last served and another Medical Officer shall be posted in that place to fulfill the Medical Council of India Norms.”

iii) For the existing para 3 (ix) the following shall be substituted:-

“(ix) The selection of these candidates shall be handed over to the Secretary, Selection Committee for selection and admission of candidates as being done for selection of candidates for Post Graduate Medical Courses”

4. The Director of Medical Education and Additional Director of Medical Education / Secretary, Selection Committee is directed to take necessary action accordingly.
