Diploma in Nursing course at Trichy with an annual intake of 20 students from the academic year 2008-2009.

In Government Order sixth read above, permission was accorded to the Managing Trustee, Kaveri Medical Trust, Trichy increasing the Diploma in General Nursing and Midwifery (DGNM) seats from 20 to 40 at KMC School of Nursing, 45/2A, Manikandam, Trichy District from the academic year 2018-2019. The Tamil Nadu Nurses and Midwives Council, Chennai has recognized 40 seats of Diploma in General Nursing and Midwifery course to the above institution.

3. In Government Order seventh read above, permission was accorded to the Managing Trustee, Kaveri Medical Trust, Trichy for increasing of B.Sc (Nursing) seats from 40 to 100 at KMC College of Nursing, 45/2A, Manikandam, Trichy District from the academic year 2018-2019.

4. The Chairman, Kavery Medical Trust, Trichy at KMC School & College of Nursing, Trichy has requested the Government to grant permission for change of address from No.45/2A, Manikandam, Trichy-620 012 to No.91, Navalur Kuttapattu Village, Dindigul Main Road, Trichy-620 009.

5. In Government letter nineth read above, the Director of Medical Education was requested to conduct an inspection at the premises of the Trust for considering their request. In his letter tenth read above, the Director of Medical Education has submitted the proposal wherein he has stated that the inspection team has conducted an inspection at the premises and submitted their report by stating that the said institution has fulfilled all the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi. Hence, the Director of Medical Education has recommended to give permission to the Chairman, Kavery Medical Trust, Trichy at KMC School & College of Nursing, Trichy for change of address from No.45/2A, Manikandam, Trichy-620 012 to No.91, Navalur Kuttapattu Village, Dindigul Main Road, Trichy-620 009.

7. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education. with other general conditions laid down in G.O (Ms) No.219, Health and Family Welfare (PME.2) Department, dated: 06.06.2018 as applicable to this proposal before admitting the students:-

- i. The Trust should obtain building plan approval from the Directorate of Town and Country Planning for the KMC School & College of Nursing.
- ii. The Trust should obtain affiliation from the Tamil Nadu Dr. M.G.R. Medical University and if needed, suitability from Indian Nursing Council, New Delhi, respectively before admitting the students.
