In the G.O 1st read above, among other things, orders were issued forming a new Department called Food Safety and Drug Administration Department along with certain newly created post.

The Commissioner of Food Safety and Drug Administration Department has requested the Government to transfer the Six Food Analysis Laboratories at Guindy, Thanjavur, Madurai, Palayamkottai, Salem and Coimbatore along with the existing posts sanctioned under Prevention of Food Adulteration Act, 1954, now functioning under the control of the Director of Public Health and Preventive Medicine to the new Department of Tamil Nadu Food Safety and Drug Administration Department.

The Government after the detailed examination, accord sanction for the transfer of the Six Food Analysis Laboratories along with the existing posts sanctioned under Prevention of Food Adulteration Act, 1954, and incumbents from the control of the Director of Public Health and Preventive Medicine to the Commissioner of Tamil Nadu Food Safety and Drug Administration.
